- Auditor General's report and audit opinion received for the Financial year 2022/23. Audit opinion – Qualified. It was drawn to the Council's attention that the Governance Statement has not been added to the website. This, together with the conclusion of audit will be added to the website. Also, as this was a Full Audit, an audit fee of £825.00 has been charged. This was considered, decided and passed unanimously by the Councillors that this fee will not be paid until the end of the year when all preceptst have been received due to the level of funds in the account.

To establish an appropriate system of internal control to safeguard the money and assets held by Llanwnnen Community Council the Standing Orders were read and discussed in detail.
